# **ENGAGING MEN IN SRHR:** PRIORITISING ISSUES AND **DEVELOPING CONTENT**

The FPAI Headquarters, Access Unit, conducted a workshop on March 31 and April 1, 2015 at Panchkula. The objectives were to understand the role of men in SRHR, and to develop messages and material for engaging males to address Gender Based Violence (GBV) and enabling them to seek SRH services. Teams from Agra, Yamunangar, Mohali and Panchkula Branches participated in the workshop. The concepts covered include: Masculinity and its link with GBV, SRH for men and engaging men in SRHR. Key messages and slogans were developed through discussions, and they would be used in the IEC material.

The deliberations focused on the why, what and how of engaging with men to prevent GBV and encourage men to seek SRH services, while supporting their partners. Participants brought in their perspective of local situations and developed slogans. This collective exercise of brainstorming to develop material was appreciated.

The Panchkula Branch will sift through the session outputand develop IEC material, which would be reviewed and finalized by the Headquarters. As next steps, two clear themes emerged: Engaging men to prevent GBV and encouraging them to seek SRH services. Common myths onsexuality, information on key components of SRH for men like contraception, prevention and management of STI/RTI/HIV, taking equal responsibility for SRH issues – all would be included in IEC material.

## MEETING ON 'HIV STRATEGY **DEVELOPMENT FOR** NORTH EAST INDIA'

The meeting was organised by National AIDS Control Organisation (NACO) in Shillong, on April 22 and 23, 2015, to finalise statespecific plans. Ms. Nisha Jagdish, Director-HIV, made a presentation on HIV interventions initiated by FPAI. Outcome: NACO requested FPAI to provide them technical support in SRH and to expand our work in the North East.

FP2020 -**MEETING WITH CIVIL SOCIETY** 

A 'Meeting with Civil Society' was organized on April 22, 2015 at New Delhi. FP2020 activities emphasise a rights-based approach to family planning programmes.

first time the Reference Group (RG) met in an FP2020 committed country.

This meeting, attended by Ms. Geeta Sethi, Secretary General, and Mr. Sreedharan Nair, Director, External Relations, enabled Civil Society Organizations (CSOs) to engage with the RG and share their experiences on implementing family planning at all levels; and to explain how CSOs can support better. Others present include: RG Co-Chair Dr. Babatunde Osotimehin, Executive Director of UNFPA; RG Co-Chair Dr. Chris Elias, President of Global Development at the Bill & Melinda Gates Mr. Simon Cooke, CEO, Marie Stopes International; Mr. Tewodros Melesse, Director, International Planned Parenthood Federation (IPPF); Ms. Poonam Muttreja, Executive Director, Population Foundation of India; Mr. C K Mishra, Additional Secretary, Ministry of Health and Family Welfare, Government of India. Youth volunteers of FPAI-New Delhi also took part.

# - NATIONAL MEETING ON CITIZEN'S PARTICIPATION AND ENGAGEMENT FOR IMPROVING WOMEN'S AND CHILDREN'S HEALTH

White Ribbon Alliance-India organised a national meeting in partnership with FPAI, IPPF-SARO, Centre for Catalysing Change, Plan India, Save the Children, and World Vision India with the objectives ofdrawing attention to safe motherhood and citizens' participation to achieve it; and appealing to citizens, governments and NGOs to develop an action plan to address the health of women and children. FPAlwas represented by Mr. Sreedharan Nair, Director External Relations; Mr. Subhash Khake, Coordinator, Regional Resource Centre; and Ms. Bindiya Nimla, Director, Advocacy and Training.

Mr. Raghav Chadha, Spokesperson, Aam Admi Party (AAP), spoke on participatory governance. Dr. Rakesh Kumar, Joint Secretary (RCH), Ministry of Health & Family Welfare, Government of India, who was the Chief Guest, mentioned that maternal mortality declined by

70% in the period 1990-2012. Newborn deaths have reduced from 327/100,000 to 167/100,000. Child mortality is down to 52/1000 from 114/1000. He called for people to be more responsive and demanding for entitlements and quality health services. Mr. Amitabh Behar, Executive Director, National Foundation of India, spoke on the process and opportunities for citizen engagement. CSOs' engagement in Sustainable Development Goals (SDGs) consultations has been limited. There is aneed for a citizens' campaign to include civil society in discussions related to SDGs.

This was followed by a panel discussion and open forum, with recommendations on how citizens and government can engage on women and children's health.



**CONSULTATIONS ON** POST 2015 DEVELOPMENT AGENDA WITH PARLIAMENTARIANS AND **KEY STAKEHOLDERS** 

> FPAI and Indian Association of Parliamentarians for Population and Development (IAPPD) organised Consultation on Po consultative meetings with with Parliament Parliamentarians and other Key Stakehol key stakeholders in New Delhi (June 9), Bhubaneswar (June 24) and Chandigarh (June 26). The objective was to initiate a dialogue with Parliamentarians and other stakeholders in articulating the Post-2015 development agenda with focus on Sexual and Reproductive

> > Health and Rights (SRHR), and work on the

Sustainable Development Goals (SDGs).

On June 9, Ms. Geeta Sethi, Secretary General, set the context: "These (Sustainable Development) goals were developed by a participatory process... Each one of us has an important role to play in getting what we would like to have... Sexual and Reproductive Health are not explicit in these goals and still they are (an) integral part of health...Various sectors need to be included to see the linkages...share the challenges and see what is achievable for a better world." The Chief Guest, Prof. P J Kurien, Deputy Chairman of Rajya Sabha, said: "We have made considerable achievement in MDGs but Maternal Mortality and Infant Mortality still exists. There is a need to examine to what extent we achieved MDGs and what are the impediments in our success... Let us not go for another set of goals after 15 years...Let's achieve these SDGs this time... One of the biggest impediments in achieving MDG targets including MDGs 4 and 5 is the exponential growth of population... It is important to encourage contraception, spacing of pregnancies, and access to information on sexual issues. I also welcome the step of Government of Karnataka for providing sexual education to young people."



In his keynote address, Dr. Rakesh Kumar, Joint Secretary (RCH), Ministry of Health, shared, "With an annual reduction of 6.5% in Maternal Mortality, India has performed much better than the global average. Against the MDG 5 target of 140, India at present is reporting an MMR of 167 maternal deaths per 100,000 live births. There are higher chances that India will achieve its target for MMR. But, what is important is that not a single woman should die giving birth. A pregnant woman gives nine months' notice and still she dies. With one-third of girls getting married before 18, child-marriage continues to pose one of the major problems for the country. India is one of youngest countries with 2.3 million adolescents. To make the SDGs a success and address the unfinished agenda of MDGs, we have to focus on health and education of adolescents."

The MPs and MLAs agreed that making Parliamentarians aware of the post 2015 global development agenda is key. They are the link between people and the government and hence

important to setting goals/policies and achieving them.

> At the OdishaState Level Consultation in Bhubaneswar, Mr. Baijayant Panda, MP, said in his inaugural address: "Goals and targets are self-chosen. It serves as a marker. We have to create the journey to reach the goal... Need for operational planning and implementation. Challenge is to speed up, as we have diversity in our democracy. Economic growth depends upon all sorts of

development. Need to improve creation of jobs. In addition to economic growth, we need to be conscious about sustainable issues and renewable resources." The event was hosted by FPAI Bhubaneswar Branch, with attendance from Kolkata and SinghbhumBranche-

Mr. Kunwar Pal Gujjar, Haryana Vidhan Sabha Speaker, called for stronger laws to ensure SRH of women; and for all political parties to work collectively in the national interest. The Haryana State Level Consultation, hosted by FPAI Panchkula Branch, was also attended by Agra, Ahmedabad, Yamunanagar, and Mohali Branches. Dr. Kalpana Apte, Senior Secretary General, Programme Implementation, stressed: "Post 2015 development agenda must include the unfinished agenda from MDGs and ensure that 'no one is left behind' - maternal health, comprehensive sexuality education and reproductive rights are important."

Mr. Umesh Aradhya, President, FPAI opined: "Post 2015 development agenda in India should be focused on state level variations and priorities. We hope that our MPs and MLAs would raise these important issues in Parliament and legislative assemblies for formulating proper policies."

The consultations received wide media coverage (print and electronic) both in English and local languages.

Joining Voices is an advocacy project initiated by International Planned Parenthood Federation (IPPF) that aims to safeguard and strengthen financial commitments to reproductive health and family planning, and reinforce political leadership on universal access.
